LETTER OF PERMISSION

Sub:- Establishment of New Self Finance Medical College at Visnagar, Dist. - Mehsana, Gujarat (Nootan Medical College & Research Centre) by Nootan Sarva Vidyalaya Kelvani Mandal, Visnagar, Gujarat u/s 10A of the IMC Act, 1956 for the academic year 2019-20.

Sir/Madam,

In continuation to this office letter No.MCI-34(41)(E-11)/2018-Med/387164 dated 13/03/2019 and your letter No.NMC/Gen./MCI/268/2019, dated 19/03/2019 furnishing required undertaking/Bank Guarantee, I am directed to convey the formal permission of the Board of Governors for establishment of a new medical college at Visnagar, Dist. - Mehsana, Gujarat in the name and style of "Nootan Medical College & Research Centre, Visnagar" with annual intake of 150 MBBS students for the academic year 2019-2020 under Section 10A of the Indian Medical Council Act, 1956.

2. This permission of the Board of Governors in supersession of the MCI accorded initially for a period of one year and will be renewed on yearly basis subject to verification of achievement of annual targets as indicated in your scheme. This process of renewal of permission will continue till such time the infrastructure and expansion of hospital facilities are completed as per norms of Medical Council of India and the college is recognized. The next batch of students shall be admitted only after obtaining permission of the Board of Governors in supersession of the MCI.

3. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.

4. Discrepancies, if any, may be immediately brought to the notice of the Board of Governors in supersession of the MCI and the State Govt.
