Subject: Renewal of Undergraduate Seats (MBBS) of Nootan Medical College and Research Centre, Mehsana, for the year AY-2025-26 - regarding.

Sir/Madam,

I am directed to refer to the Public Notice issued by UGMEB vide dated 01.11.2024 uploaded on the NMC website on 06.11.2024, directing all medical colleges with valid Letters of Permission (LoP) to upload the details/data of their respective institutions on the NMC portal for the annual declaration, as required under the NMC Act, 2019 and various regulations issued by NMC from time to time, for the grant of renewal of MBBS seats for the academic year 2025-26.

2. Based on the details furnished by your college, the experts assessed the submissions, and accordingly, a Notice dated **11.05.2025** was issued highlighting the following deficiencies observed during the assessment:

- i. 19 out of 19 Departments are deficient in Faculty, SR and Demonstrator/Tutor and 17 out of 19 departments are deficient in above post considering 50-75% attendance window.
- ii. Blood bank license has expired on 09/09/2023. Its current status need to be verified.
- iii. Number of cadavers claimed to be 13 in year 2024 but registration number doesn't reflect the same as none of the cadavers have registration no. of 2024, all one of year 2022 &

2023.

- iv. Bed occupancy is 78.44% against minimum required 80%.
- v. Inadequate hematology & clinical pathology investigations.
- vi. FAP visits for 2023-24 batches are declared to be one. It doesn't meet criteria of 8 visits of 3 hr each or 4 visits of 6 hr each in phase I.

3. Subsequently, the compliance report submitted by your Institution was also evaluated by the Assessors; however, amongst other deficiencies, following key deficiencies were again highlighted w.r.t. your College/Institution:

- i. Some departments are still deficient in faculty/Resident/tutor as per AEBAS record data, however your explanation has been accepted therefore, the college may adhere to the deficiencies found in the AEBAS
- ii. Cadavers are still deficient.
- iii. Bed occupancy is still deficient.
- iv. Hematology and clinical investigations are still less than benchmark requirement.

Further, it has been observed that during the renewal process for the previous year AY 2024-25, Penalty was imposed and conditional renewal was granted in view of the substantive nature of deficiencies in your College.

4. The Competent Authority has reviewed the Annual Declaration Report (ADR) submitted by your college/institutions and also the deficiencies pointed out by the experts. The compliance report submitted by the college has not been found to be convincing and satisfactory.

5. However, UGMEB has taken a lenient view and **decided to grant conditional renewal of 150 UG (MBBS) seats** for the academic year 2025-26, **subject to rectification of deficiencies within four months from the issuance of this letter.**

6. A further review will be conducted after four months, and if the deficiencies are found to persist at that time, stringent action will be initiated as mandated under Chapter III, Clause 8 of the Maintenance of Standards of Medical Education Regulations (MSMER), 2023, and any other applicable rules or regulations.

7. If the College/Institution is not satisfied and aggrieved with the decision of the Board, you may prefer an appeal before the Commission under Section 9, Chapter IV of the Maintenance of Standards of Medical Education Regulations, 2023, (MSMER, 2023) within Sixty (60) days of the issue of this letter.
